REQUEST FOR RELEASE OF FUNDS

On or about October 21, 2025, Polk County (County) will submit a request to the Texas General Land Office (TGLO) for the release of Community Development Block Grant funds under Community Development Block Grant Mitigation ("CDBG-MIT") appropriated under Supplemental Appropriations for Disaster Relief Requirements Act, 2018 Public Law 115-123 as amended, to undertake a project known as Polk County 2023 Facility Improvements, for Contract 24-065-044-E536 / B-18-DP-48-0002. Project Description, Purpose and Need:

County shall demolish the existing Polk County building(s) with asbestos and lead abatement, construct an approximately 4250 Sq Ft shelter of last resort, reinforced concrete paving, install utilities and fire sprinkler system, sidewalks, signage, pave and stripe road, and complete associated appurtenances. This is a critical action project. Clearance includes administration, engineering and environmental activities. Total Acres of Disturbance: 0.53 acre. Project location is 602 East Church Street/ US Hwy 190 Livingston, Texas 77351 Lat/Long: 30.709816, -94.9264119. The purpose of this project is to provide a safe place for underserved, disadvantaged and socially vulnerable groups in need of shelter during times of extreme urgent circumstances including significant weather events.

ENVIRONMENTAL CERTIFICATION

Polk County certifies to TGLO that Sydney Murphy in her capacity as Judge consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. TGLO's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows County to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

TGLO will accept objections to its release of fund and the Polk County certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of Polk County (b) County has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by TGLO; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to Heather Lagrone, Texas General Land Office, PO Box 12873, Austin, TX 78711-2873, env.reviews@recovery.texas.gov. Potential objectors should contact TGLO to verify the actual last day of the objection period.
